AGENDA AND MINUTES

In attendance: Board of Supervisors members: Richard Lunt, Chairman, David Gomez, Member and Ron Campbell, Member. Also present were Scott Adams, County Attorney, Derek Rapier, County Administrator, Austin Adams, HR Director and Bianca Figueroa, Clerk of the Board

1.) Call to Order

Chairman Richard Lunt called the meeting to order at 8:07 a.m.

A. Pledge of Allegiance

Supervisor Gomez led those present in the pledge.

B. Call to the Public

Barbara Waddell Reyes with Greenlee County Tourism Council responded to call to the public, she stated they received a grant for \$125,000.00 from FMI for restoration on the San Francisco River and explained the council would like to get the community involved.

Jean Schwennesen with the Engineer Department, dicussed the cost of community services.

Will Collins, Greenlee County Tourism Council responded to call to the public and stated the San Francisco restoration festival kickoff be March 17th from 11am to 6:30 pm in Clifton near the splash pad. Asked for support from the Sheriff's Office.

Nancy Welker, from Bowie Arizona responded to call to the public, she thanked the board for 17 years of their continued support for the Sunzia Powerline project.

Daniel Cervantes, Clifton resident responded to call to the public, acknowledged Mr. Rapiers history as an attorney with Greenlee County also acknowledge is current position as the County Administrator and gave his appreciation for his service.

Sheriff Sumner responded to call to the public and discussed an abandon vehicle on Ward Canyon road and stated that he has not received some Zoom videos he has requested.

2.) PUBLIC HEALTH SERVICES DISTRICT – the Board of Supervisors will convene as the Board of Directors of the Greenlee County Public Health Services District and will reconvene as the Board of Supervisors following consideration of these items:

A. Consent Agenda

- 1. Clerk of the Board: Consideration of approval of Public Health Services District expense warrants in excess of \$1,000.00
- 2. Health Manager: Consideration of approval of the Employee Transaction Form: K. Palomarez, CNA

Mr. Sumner responded and expressed his concerns regarding the Employee Transaction Form with discrepancies.

Upon motion by Supervisor Campbell seconded by Supervisor Gomez, and carried unanimously, the Board tabled agenda item 2.A.2 for the next board meeting with the corrections.

Upon motion by Supervisor Campbell seconded by Supervisor Gomez and carried unanimously, the Board approved the Public Health Services District Consent Agenda as presented after tabling 2.A.2.

- 3.) FLOOD CONTROL DISTRICT the Board of Supervisors will convene as the Board of Directors of the Greenlee County Flood Control District and will reconvene as the Board of Supervisors following consideration of these items:
 - A. Consent Agenda
 - 1. Clerk of the Board: Consideration of approval of Flood Control District expense warrants in excess of \$1,000.00

Upon motion by Supervisor Gomez seconded by Supervisor Campbell, and carried unanimously, the Board approved the Flood Control District Consent Agenda as presented.

- 4.) Matt Bolinger, Health Director
 - A. Discussion/Action regarding pay increase of \$.90 per hour for CNA employees funded by increased funding from SEAGO.
 - Mr. Sumner spoke on the agenda item and suggested funds also go to EMS if funding can be extended to EMS workers.
 - Mr. Bolinger discussed a proposed funding increase from SEAGO. He explained the difficulties of hiring CNA's in our rural county. The pay increase is .90 cent increase per hour for the direct contact care workers. Increase will start in January of 2023 if accepted, and fully funded by SEAGO. It was also explained that these funds can only be used for the county's CAN program.

Upon motion by Supervisor Gomez seconded by Supervisor Campbell, and carried unanimously, the Board approved the agenda item as presented.

5.) Derek Rapier, County Administrator A. County and State budget and legislative issues

Mr. Rapier stated the Senate passed a "continuing funding" budget, which is to take last year's budget without last year's one-time spending and enact it again. However, it was not passed by the House. He discussed and highlighted some legislative issues and concerns which may affect Greenlee County. Mr. Rapier explained county budget will need to account for a slowing economy, and slowing revenue from both shared sales taxes and half-cent sales tax.

Upon motion by Supervisor Gomez seconded by Supervisor Campbell, and carried unanimously, the Board approved the consent agenda.

7.) Supervisor Reports (Pursuant to A.R.S. §38-431.02(K), individual supervisors may present brief summaries of current events, but no discussion may occur, and no action may be taken regarding anything that is presented.

Chairman Lunt attended the LPC meeting where relevant bills were discussed and he reported that as of last Friday, Jan 31, 1,328 bills had been filed. The Senate deadline to drop bills was on the Jan 30th and the House's deadline is today. Chairman Lunt stated several bills are still being tracked.

8.) EXECUTIVE SESSION - pursuant to Arizona Revised Statues §38-431.03(A)(1) for the Board to discuss employment review of the County Administrator

Sheriff Sumner commented on this agenda item, he presented minutes from a prior Board meeting and a document he had previously presented. He expressed his concerns regarding Mr. Rapier and made suggestions for his evaluation.

Supervisor Gomez moved to go into executive session to consider the topic listed in the agenda. Supervisor Campbell seconded the motion which carried unanimously.

The Board adjourned out of executive session.

9.) Adjournment

There being no further business to come before the Board of Supervisors, the meeting was adjourned at 10:12 a.m.
