March 7, 2013

The Greenlee County Board of Supervisors met on this date in regular session with the following members present: David Gomez, Chairman; Ron Campbell, Member; and Robert Corbell, Member. Also present were Deborah K. Gale, County Administrator, who appeared telephonically, and Yvonne Pearson, Clerk of the Board.

Chairman Gomez called the meeting to order at 10:00 a.m. and Supervisor Corbell led those present in the Pledge of Allegiance.

Supervisor Corbell reported the following:

A. He attended a meeting regarding the Apache County Predator Issue. He stated that approximately 400 persons were in attendance. Speakers included representatives from the Ranching Heritage Alliance, Arizona Cattle Growers Association, Catron County, New Mexico, Apache County, Texas Livestock Grazers, and San Carlos Reservation. The topic of discussion included the effect the wolf has on the health, safety and welfare of citizens. Lethal removal, translocation, and psychological effects on kids, ranchers and the public discussion also took place.

Supervisor Campbell reported the following:

A. He attended the County Supervisors Association Legislative Policy Committee teleconference meeting where proposed legislative bills were

reviewed to determine support or opposition and the effect each bill has on counties was also discussed.

Supervisor Gomez reported the following:

- A. He attended the SouthEastern Arizona Governments Organization (SEAGO) meeting where discussion took place regarding the audit of the organization. He stated that the audit revealed only one finding reflecting a significant improvement. SEAGO Board members were elected with Supervisor Molera of Santa Cruz County elected as Chairman and Supervisor Gomez elected as 1st Vice Chairman. Resolution #2013-01 was adopted urging the legislature and Governor to direct dedicated transportation funding such as Highway User Revenue Funds (HURF) to the intended use. The next meeting will take place in Bisbee at the new SEAGO Office Building.
- B. The Growing Greenlee Business Opportunity Forum will take place this week on Friday with several speakers scheduled to attend. The forum will showcase Greenlee County to lure potential businesses into our county. Housing developers and hoteliers are among the several people who have registered to attend. He stated that he feels that something good will come of this forum.

There being no further business to come before the Board of Supervisors, the meeting was adjourned at 10:24 a.m.
