## GREENLEE COUNTY BOARD OF SUPERVISOSRS CLIFTON, ARIZONA

April 1, 2011

The Greenlee County Board of Supervisors met on this date in special session in the Board Meeting Room, 2<sup>nd</sup> floor Courthouse Annex, Clifton, Arizona, with the following members present: David Gomez, Vice Chairman and Richard Lunt, Member. Also present were Deborah K. Gale, County Administrator, and Yvonne Pearson, Clerk of the Board.

Vice Chairman Gomez called the meeting to order at 8:00 a.m. and Supervisor Lunt led those present in the Pledge of Allegiance.

Ms. Gale responded to the Call to the Public asking everyone to keep our troops in their thoughts and prayers. She also asked everyone present to take advantage of the Spring Rampage event today and tomorrow.

Mr. Robert Corbell, citizen, responded to the Call to the Public and expressed his interest in the position of Board of Supervisors, District 2, and asked that the Board take this into consideration. Mr. Corbell submitted petitions with signatures of citizens indicating their support of Mr. Corbell.

Upon motion by Supervisor Lunt, seconded by Supervisor Gomez, and carried unanimously, the Board accepted the Letter of Resignation from Hector Ruedas, Chairman, Board of Supervisors, District 2, effective March 31, 2011.

Upon motion by Supervisor Lunt, seconded by Supervisor Gomez, and carried unanimously, the Board declared a vacancy on the Board of Supervisors from District 2.

Supervisor Lunt stated that he has heard from and received calls from persons showing an interest in being considered to fill the vacancy on the Board of Supervisors. The Board has also received three (3) resumes and a set of petitions from interested person. Supervisor Lunt stated that he has worked with Hector Ruedas on the Board of Supervisors for many years and he trusts and respects his judgment. Supervisor Lunt motioned to accept the recommendation submitted by Mr. Ruedas for the appointment of Mr. Ron Campbell to fill the vacancy.

Supervisor Gomez stated that historically when an elected official has vacated their position before the end of their term, the recommendation of that elected to fill the vacancy of that elected office has been accepted.

Supervisor Gomez seconded the motion to appoint Mr. Ron Campbell to fill the vacancy on the Board of Supervisors in District 2. The motion carried with both members of the Board and the Clerk of the Board voting aye.
