work sessions and that they are included in the tentative budget which the Board would consider on July 6, 2022.

Mr. Rapier also discussed last minute State budget legislation that would affect Greenlee's budget. The first was a State budget appropriation for retention and recruitment stipends for Sheriff's Office deputies and detention staff. He indicated that because there are so many unanswered questions about how this will be implemented and who will be responsible for unanticipated additional costs, he explained that he has budgeted funds to be able to cover the costs associated with this legislation with hopes that the State will backfill all or most of the expenditures. The second issue he discussed was that the State passed the change to out of county tuition reimbursement that the County had been lobbying for a couple of years and that it appeared that some unanticipated revenue to help cover the cost of the reimbursement amount was also added by the legislature. However, because of the uncertainty of the reimbursement, he did not include it in the budget.

There being no further business to come before the Board of Supervisors, the meeting was adjourned at 4:25 p.m.
