In attendance: Board of Supervisors members: Richard Lunt, Chairman, David Gomez, Member and Ron Campbell, Member. Also present were Scott Adams, County Attorney, Derek Rapier, County Administrator, Austin Adams, HR Director and Bianca Figueroa, Clerk of the Board

1.) Call to Order

Chairman Richard Lunt called the meeting to order at 8:00 a.m.

A. Pledge of Allegiance

Supervisor Gomez led those present in the pledge.

B. Call to the Public

Daniel Cervantes, Clifton resident responded to call to the public and discussed the upcoming Election, candidates and newly elected officials. He suggested a celebration for those retiring and those newly elected.

Tim Sumner, County Sheriff responded to call to the public, discussed typos on website, discussed his ongoing public records request and concerns with records that have not been sent yet, also discussed the previous meeting regarding an Elected Officials presentation.

2.) PUBLIC HEALTH SERVICES DISTRICT – the Board of Supervisors will convene as the Board of Directors of the Greenlee County Public Health Services District and will reconvene as the Board of Supervisors following consideration of these items:

A. Consent Agenda

1. Clerk of the Board: Consideration of approval of Public Health Services District expense warrants in excess of \$1,000.00

Upon motion by Supervisor Gomez, seconded by Supervisor Campbell, and carried unanimously, the Board approved the Public Health Services District Consent Agenda as presented.

3.) Derek Rapier, County Administrator

A. Consideration of Commitment by Greenlee County to Contribute to The National Center for Public Lands Counties (The Center)

Mr. Rapier gave a brief discussion regarding the National Public Lands Center concept which is to form a non-profit organization to conduct research on public lands issues important to western states and western counties, asking for funding from counties equivalent to 1% of LACTF funds but using the county's general fund which would be backfilled with LACTF funds. Greenlee's commitment would be roughly \$30,000 and there is sufficient contingency funding to meet this commitment. Mr. Rapier recommended the board to make a commitment to the concept, and fund the program once the details are available.

Chairman Lunt explained that the federal government decided that public land counties have additional public lands responsibilities and therefore funded additional ARPA money for these purposes in the LACTF allocation. He explained how the proposed program would help counties and how funding will help with more accurate and extensive public lands research.

Upon motion by Supervisor Campbell seconded by Supervisor Gomez and carried unanimously, the Board approved its commitment to the concept of the The National Public Lands Center and to consider funding its commitment when the program is ready to receive funds.

4.) PUBLIC HEARING - Requested action by Gabriel Corona to change the zoning district of Parcel Number 300-90-004 from TR-18 (transition, minimum lot area 18,000 sq. ft.) to MH-18 (mobile home, recreational vehicle parks, minimum lot area 1,800 sq. ft.)

Supervisor Gomez moved to go into public hearing on the requested zoning change and Supervisor Campbell seconded the motion. The motion carried unanimously.

No member of the public commented during the public hearing.

5.) Hayden LaFoy, Planning and Zoning

A. Discussion/Action regarding the request by Gabriel Corona to change the zoning district of Parcel Number 300-90-004 from TR-18 (transition, minimum lot area 18,000 sq. ft.) to MH-18 (mobile home, recreational vehicle parks, minimum lot area 1,800 sq. ft.)

Ms. LaFoy stated at their Planning & Zoning meeting a comment was made by Nancy Spencer Morris regarding water table and global warming, after her comments were presented, the commission did vote to recommend the change unanimously.

Upon motion by Supervisor Campbell, seconded by Supervisor Gomez, and carried unanimously, the Board approved the zoning change as presented.

6.) PUBLIC HEARING - Requested action by Anthony Sedgeman to change the zoning district of Parcel Number 300-66-009D from RU – 36 (rural, minimum lot area 36 acres) to SR – 43 (single-household residential, minimum lot area 43,650 sq. ft)

Supervisor Gomez moved to go into public hearing on the requested zoning change and Supervisor Campbell seconded the motion. The motion carried unanimously.

No member of the public commented during the public hearing.

7.) Hayden, LaFoy – Planning and Zoning

A. Discussion/Action regarding the request by Anthony Sedgeman to change the zoning district of Parcel Number 300-66-009D from RU – 36 (rural, minimum lot area 36 acres) to SR-43 (single-household residential, minimum lot area 43,650 sq. ft)

Ms. LaFoy stated the request had unanimous approval by the commission, and stated Ms. Spencer Morris had the same comments as before.

Mr. Rapier asked Mr. LaFoy if Ms. Morris is within the 300ft notice zone of the parcels she's commented on. Ms. LaFoy said that Ms. Morris is not.

Upon motion by Supervisor Campbell, seconded by Supervisor Gomez, and carried unanimously, the Board approved the zoning change as presented.

8.) PUBLIC HEARING – Requested action to consider a request by Brian and Leticia Sedgeman to change the zoning district of Parcel Number 300-66-009G from RU-36 (rural, minimum lot area 36 acres) to SR-43 (single-household residential, minimum lot area 43,650 sq. ft.)

Supervisor Gomez moved to go into public hearing on the requested zoning change and Supervisor Campbell seconded the motion. The motion carried unanimously.

No member of the public commented during the public hearing.

9.) Hayden, LaFoy – Planning and Zoning
A. Discussion/Action to consider a request by Brian and Leticia
Sedgeman to change the zoning district of Parcel Number 300-66-009G
from RU -36 (rural, minimum lot area 36 acres) to SR-43 (single-household residential, minimum lot area 43,650 sq. ft.)

Ms. LaFoy stated Ms. Spencer Morris had the same comments, and the Planning and Zoning commission unanimously recommended approval.

Upon motion by Supervisor Campbell, seconded by Supervisor Gomez, and carried unanimously, the Board approved the zoning change as presented.

10.) PUBLIC HEARING -Requested action to consider request by Joseph and Lisa Freeman to change the zoning district of Parcel Number 400-60-011 from RU-36 (rural, minimum lot area 36 acres) to RU-4 (rural, minimum lot area 4 acres)

Supervisor Gomez moved to go into public hearing on the requested zoning change and Supervisor Campbell seconded the motion. The motion carried unanimously.

No member of the public commented during the public hearing.

11.) Hayden, LaFoy – Planning and Zoning

A. Discussion/Action regarding request by Joseph and Lisa Freeman to change the zoning district of Parcel Number 400-60-011 from RU-36 (rural, minimum lot area 36 acres) to RU-4 (rural, minimum lot area 4 acres

Ms. LaFoy stated it was a uniramous recommendation for approval by the commission and no comments.

Upon motion by Supervisor Campbell, seconded by Supervisor Gomez, and carried unanimously, the Board approved the zoning change as presented.

12.) PUBLIC HEARING – Requested action to consider request by Anderson Barnes to change the zoning district of Parcel Number 300-50-055 from RU-36 (rural, minimum lot are 36 acres) to MR-A (multiple-household residential, minimum lot area 6,000 sq. ft.)

Supervisor Gomez moved to go into public hearing on the requested zoning change and Supervisor Campbell seconded the motion. The motion carried unanimously.

No member of the public commented during the public hearing.

13.) Hayden, LaFoy – Planning and Zoning

A. Discussion/Action regarding request by Anderson Barnes to change the zoning district of Parcel Number 300-50-055 from RU-36 (rural, minimum lot are 36 acres) to MR-A (multiple-household residential, minimum lot area 6,000 sq. ft.)

Ms. Lafoy stated Ms. Spencer Morris gave input and after consideration of the comments the commission unanimously recommended approval.

Chairman Lunt asked again if Ms. Spencer Morris fell into the 300ft area of the parcels she commented on, Ms. LaFoy stated she did not.

Upon motion by Supervisor Campbell, seconded by Supervisor Gomez, and carried unanimously, the Board approved the zoning change as presented.

A. County and State budget and legislative issues
