November 1, 2012

The Greenlee County Board of Supervisors met on this date in regular session in the Board Meeting Room, 2nd floor Courthouse Annex, Clifton, Arizona, with the following members present: David Gomez, Vice Chairman; and Ron Campbell, Member. Supervisor Richard Lunt attended the meeting telephonically. Also present was Deborah K. Gale, County Administrator, and Yvonne Pearson, Clerk of the Board.

Vice Chairman Gomez called the meeting to order at 8:00 a.m. and Supervisor Campbell led those present in the Pledge of Allegiance.

Ms. Gale responded to the Call to the Public asking everyone to pray for the citizens dealing with the devastating damage caused by Hurricane Sandy on the East Coast.

Karla Ellis, Fair & Racing Director, responded to the Call to the Public and reviewed the income and expense statement for the County Fair. The County Fair brought in a total of \$2,555.15 profit after all expenses were paid. She stated that the livestock sales went extremely well. The Board expressed their appreciation to the entire Public Works staff for a job well done.

The Board convened as the Board of Directors of the Greenlee County Public Health Services District and upon motion by Supervisor Campbell, seconded by Supervisor Lunt, and carried unanimously, the Board approved the Public Health Services District Consent Agenda as follows:

- B. He attended the SouthEastern Arizona Governments Organizations (SEAGO) meeting and stated that the organization will be in their new office in January and that Graham County will host the next meeting.

He also stated that he attended the Workforce Investment Act (WIA) Governors Council meeting where the merger of Greenlee, Graham and Cochise WIA is coming along very well.

Supervisor Campbell reported the following:

A. He attended a meeting with the management team and cooperators regarding the Mexican Wolf where the focus was on the replacement of wolves that have been taken illegally. The goal is to have 100 wolves in the wild where there is current 58 with 42 collared.
