Asphalt Emulsion Specification

Vender shall deliver product in full truck loads and spread at a rate directed by the County Public Works Manager on a prepared road bed within Southern Greenlee County. Equipment used for spreading shall be suitable to accurately spread emulsion to 0.01 gallon per square foot (minimum rate 0.20 gallon per square yard and a maximum rate of 1.20 gallon per square yard). For this bid, Southern Greenlee County shall be about five (5) miles on either side of U.S. 70 from the Arizona/New Mexico border to the Greenlee/Graham County line, of AZ 75 from Duncan to Three Way (U.S. 191), and of U.S. 191 from Three Way to Clifton.

Vender shall provide CRS-2 meeting or exceeding Arizona Department of Transportation specifications.

Vendor shall provide HFE-100P meeting or exceeding New Mexico Department of Transportation specifications or equivalent.

Vendor shall provide CRS-2 modified with 2% latex. CRS-2 shall meet or exceed Arizona Department of Transportation specifications as modified herein. Latex shall meet the following specifications. Vendor shall provide Latex type used with each emulsion load. Butanol (TM) NS 198 (high solids, cold polymerized cationic styrenebutadiene dispersion or approved equal has been used in the past.

Vendor shall sample each load of product as and when directed by County Engineer and shall supply test results from a qualified testing laboratory. Test results shall be accompanied by a certified statement showing that the product meets or exceeds the specifications and a Chain of Custody statement. Costs of testing shall be including as separate line. Test results shall be submitted before or with invoices. Testing unit cost shall be per sample. Any tests are at the County's will.

Product not meeting specifications may be rejected and vendor will be responsible for removing product. Vendor shall not invoice the County for rejected product.

Emulsified Asphalt CRS 2 modified with 2% Latex shall meet the following tests:

Vendor shall bid delivery cost, product per ton delivered, and an hourly rate for spreading. Vendor shall clearly state the quantity of material to be delivered upon order.

Vendor shall show a demurrage rate of one and one half (1.5) the spread rate. Demurrage will be charged whenever the vendor is scheduled to deliver product and is unable to deliver or spread due to conditions under his control including but limited to equipment failure, failure to meet these specifications, or personnel. The County will at its sole discretion make the determination when and how much demurrage will be charged.

Vendor may provide for price adjustments based on circumstances beyond vendor control including raw material cost increases. On a separate sheet of paper Vendor shall state conditions for price adjustments. No price adjustments shall be allowed if adjustment conditions are not stated.

The County may accept one or more of the Bids which is in the best interest of the County.

The County reserves the right to reject any or all bids.

The Term of the contract shall be one (1) year from the date of the Contract. The County may by mutual written amendment extend for supplemental periods of up to a maximum of eighteen (18) months
